46 least one member of the board shall be engaged in extension ministry. At least two thirds of the
47 members of the Board shall be graduates of seminaries listed by the University Senate. At least
48 two local pastors or associate members shall be named full members of the Board. **Elected**
49 **Board members may serve a maximum of three consecutive four-year terms.** It is
50 recommended that each district be represented by a member of the Board. Will elect their own
51 Chairperson according to disciplinary requirements.
